Publications and news updates

BAAT members now have access to the following BAAT publications:

- The International Journal of Art Therapy (IJAT): *Inscape* is produced quarterly and at present published online only because of COVID-19.
- Currently members also have free access to the American Journal of Art Therapy
- The members' magazine *Newsbriefing* is produced twice a year (currently published online only because of COVID-19).
