



FULL MEMBERSHIP

Full members must be qualified and registered with the Health and Care Professions Council (HCPC) as an Art therapist/ Art psychotherapist.

We strongly advise that members belong to a trade union which is affiliated to the Trade Union Congress and recommends membership of Unite for Art Therapists working in the NHS or practising independently, UNISON for those working in Social Services and Prospect for members employed in the prison service.
